
Jack Sloan is very complimentary about the work going on in the Pilot Knob community and of the part you are playing in that development. You will remember that he took some pictures there recently.

Where as the money used to purchase and maintain state parks is appropriated from tax money that is paid by Negroes as well as other citizens, and

Where as the Negro citizens of Central and South Texas need and want the use of the state parks and their facilities in the same fashion as is being used by the Anglo Saxon and Latin American groups.

Therefore be it resolved that the State Park Board and the State Legislature make the necessary changes in the present laws and present policies so that state parks will immediately become available for use by Negroes.

The following is a sample resolution:

Where as an investigation shows that there are 19 state parks in an area of 32 counties in Central and South Texas bound by Waco, Brenham, Corpus Christi and San Antonio, and

Where as these parks are owned and operated by the state of Texas and supported by public taxes, and where as these parks provide needed recreation facilities in the state, and where as these facilities are being denied to members of a minority group on the basis of race.

Therefore, be it resolved that the NAACP be instructed to investigate the matter carefully and seek the necessary redress in favor of the denied group.






