

## Negro County Agents Give 1948 Report and Program For 1949 Year

During the year of 1948, Extension Work was conducted in sixteen communities of Falls county which included farm men, women, 4-H Club girls and boys. The work was under the supervision of Jettie L. Coleman, Negro County Home Demonstration Agent and Hans E. Hill, Negro County Agricultural Agent.

Eleven Home Demonstration Council meetings, ten 4-H Club Girls' Council meetings and eight County Agricultural Council meetings were conducted. Demonstrations at these meetings included, making aprons, belts and house shoes, table arrangements and how to use sewing machine attachments. Three farm men and two club women attended the district council meeting held in Austin. Five farm men and five women attended the State Council meeting held at Prairie View. Two boys and two girls attended the Conservation camp which was held at Prairie View.

Eight method demonstrations were given to the Home Demonstration Club Women and 4-H Club girls on food preservation and storage which included meats, fruits, and vegetables. Sixteen method demonstrations were given on construction of aprons, simple dresses, alteration, and care of the sewing machine. Fourteen demonstrations were given on gardening which included production planning, control of garden insects and diseases.

Twenty eight demonstrations were given on insect and disease control among poultry, providing poultry yard equipment, culling, management and care of eggs. Thirty nine demonstrations were given on home management which included reupholstering furniture, making draperies, refinishing floors and wood work, window treatment and furniture arrangement. Nine demonstrations were given on food preparation, including home baking and preparation and serving balanced meals for the family.

Since production was the principal livestock enterprise with the farm men, demonstrations on improved practices in swine production was given the 4-H boys and men. The demonstrations consisted of care, management, feeding and selection of breeding stock. Method demonstrations were given in poultry production which included improving methods of feeding, controlling internal and external parasites, culling, improving housing and equipment. Since soil and water conservation are major problems of the farmers,

demonstrations were given on terracing, drainage, crop rotation, contour farming of crop land and application of phosphate.

As a result of the demonstrations given by the home demonstration agent and agricultural agent, improvement was shown in swine production, home gardens, crop production, clothing, preservation and preparation of foods, and improvement of the home both interior and exterior.

For 1949 more emphasis will be placed on preservation by the freezing methods since the farm women are purchasing freezing units. Demonstrations in clothing have been planned to include proper selection of material, better use of commercial patterns, better fitted garments and construction of garments. More help will be given on poultry which will include producing quality poultry and eggs, preparation and preservation of poultry. Improving the exterior and exterior portions of the home comprises a part of the home management work for 1949.

For 1949 work with the farm men and 4-H Club boys will include crop production, livestock production and conservation of natural resources.
