Dear Dr. Evans:

In line with the suggestions concurred in during our conference of May 15, I am outlining the following information concerning the status of my travel account for May and June 1942.

I am submitting my travel account for the work done in rendering assistance in organizing the Agricultural Victory Council, May 3-15, which is \$65.45. This work was done in 14 counties.

I have made an estimate of the work scheduled for the balance of the month in putting over the Pig Shows in ten counties at \$55.00. My balance as of May 1, was \$94.31, after conducting the Pig Shows, I would have a balance for June of \$42.37. However, if the expense concurred in the Agricultural Victory Council work is charged to my regular travel, at the end of May, I will have a deficit of \$23.18 as of June 1.

The estimate of expense attached to the work I propose to do the balance of May, may vary from the estimate slightly, but I doubt if there will be more than \$2.00 difference either way.

I hope I have very clearly stated the situation.

Realizing the critical period America is passing through, knowing the conditions in the various counties by personal contact with our farm people, and in view of the information disclosed by Director Williamson regarding their decision not to have a Short Course at College Station this year, we have given serious consideration to the matter relative to the Short Course for Negroes. And it is our conviction that a Short Course for Negroes is not the logical nor patriotic thing to have at this time, for the following reasons:

1. Due to the fact that the U. S. Government has asked us to conserve our tires and make our cars last longer, we feel that plans involving long trips would be disregarding this request.
2. Expense money (if the farmers have it) could be used to better advantage by defending the home front and buying defense stamps and bonds.
3. Increase in train and bus fares has made it difficult for farm women to make the trip. Most cars, and all school buses are not available because of the shortage of tires and gas.
4. Persons should stay within their localities in order to keep the Human Chain of Communication active, and the morale of the families kept high.

We hope you will consider this request favorably, and advise us immediately.

Lamb adds variety to your meals. It is a delicious and a valuable food. For directions on preparing lamb, get Starring Lamb, C-145, from the Extension Service.

wool for fluffy, warm comforts

An average sheep will produce three pounds of clean wool each year enough for a fine comfort.

During the war, you probably won't be able to get wool scoured commercially, but you can do it yourself. The Extension Service furnishes directions for washing small amounts at home. Get MS-121.

You can do as your grandmother did card washed wool into bats for comforts. If you have never done this before, likely there's someone else in your community who can help you or do it for you.

THE BATTLE AGAINST INFLATION

Perhaps the greatest battle to be fought on American soil will be the battle against inflation. Degree of success attained will go far in determining how well our civilian population can preserve the ideals at home for which men and women are fighting on foreign battlefields.

President Roosevelt and Leon Henderson are looking to the Department of Agriculture to explain to rural people the "why and how" of this large scale attack. Secretary of Agriculture Claude R. Wickard has requested the Extension Service to take the leadership in a general educational program for acquainting farm people with the government's program for holding down the cost of living and how they may do their best for the right kind of "inflation armistice".

To render maximum service in this important war effort, it will require teamwork on the part of the personnel as well as the utilization of the facilities of all Federal and State agencies, organizations, associations and institutions working in the field of agriculture. The educational work to be done under the leadership of the Extension Service will be a part of the general program being sponsored by USDA War Boards.

A series of conferences has been worked out with the State War Board. Analysis of this "enemy" and ways and means of executing the desired coordinated attack will be discussed at the State conference to be held at College Station on May 26. As a follow-up, four section conferences will be held throughout the State during the period of June 1-5.

State administrative heads of agencies, organizations, associations and departments are urged to attend the meeting at College Station. The sectional conferences are for field, district and area representatives.




