Dear Mr. Williams:


I have enough coupons in my ration book to last about one more week, I asked the clerk today about supplemental coupons but he seemed to think that I could not get any more.

The Sears pigs in Caldwell County are doing only fair. You probably remember that the pigs were of inferior quality; and they were delivered just before I started work on the annual report. These two factors combined have something to do with the lagging interest on the part of the boys who are feeding these pigs. Gilt no. 215 delivered to Henry Spriggs weighing 28 pounds on November 24th now weighs 92 pounds. This pig is probably the best Sears pig we have in the county.

Gilt number 213, delivered to S. M. Miller; weighing 58 pounds was accidentally killed on December 28th. The pig weighed 109 pounds when it was killed. The boy had the hog on the outside of the pasture trying to give the rape a chance to grow. The father came in late on that night and the hog was lying in the rut. Mr. Miller struck and killed the pig without seeing it. I would like to see S. M. have another pig. Please advise me what to do in this case.

Dear Mr. Williams:

While at Washington in November we had a conference on the matter of bringing all of the Negro supervising agents together for an orientation meeting. Since that time, the Washington and State officials have decided to hold two intraregional conferences of state Negro leaders, men and women, during the same period in which white staff extension workers will convene.

The exact date and places for holding these two conferences have not been set, but will be held during the week of April 13.

In the meantime, I have been asked to get in touch with all of the state leaders in my territory and get from each individual, at the earliest possible moment, suggestions as to what subjects you would like to have discussed in the forthcoming conference. Upon receipt of these suggestions, I am to summarize and send them to Washington so that a tentative program may be formulated and submitted to the directors for their suggestions before final notices are sent out.

I am sure you will realize the importance of quick action in this matter, because the question of locating adequate board and lodging facilities and meeting places requires considerable time after we learn where the meetings will be held.
