As I leave the Service I ask your kindest regards, and do hereby assure you of mine.


Please accept the following expression as though we were clasping hands, face to face.



Honorable Sir:

Some time ago I had a conversation with Adams, your Negro Agent, relative to the probability of starting a chain of pig programs in his county similar to the one that Sears Roebuck Agricultural Foundation has in operation in several of the South Texas counties and I suggested that he try and get his Commissioners Court to sponsor it.

This conversation came about after the Foundation had discontinued its expansion program due to the War programs and business adjustments. We have this program in operation in ten of the twenty-two South Texas counties and it has opened a wonderful opportunity to our boys and I firmly believe it will have a very stimulating effect on this type of agriculture for both adults and juniors and we are hopeful that we can get assistance in starting this program in the counties where preparation had been made to participate in the Sears plan. This plan is to give 5 registered gilts to 5 boys who had agreed to give one gilt each to another boy from their first litter. One boar is also to be given to a boy and he renders services free to these 5 gilts. This program has gone over big in the counties where it has been operating.

I am hopeful of getting this program started in the balance of the counties and we will appreciate your and the courts favorable reaction.



Dear Dr. Evans:

We are in receipt of a letter dated October 22 from Private C. W. Westbrook concerning his status with the Extension Service. Although he indicates copies of his letter were sent to you and J. H. Williams, an additional copy is enclosed. Westbrook indicates that he was under the opinion that he was being placed on a leave of absence status when he was called for military service.

Reference is here made to your letter dated September 17 in reply to Mr. G. E. Adams' letter of September 9. In accord with these letters and termination of service form filed with our office, Westbrook was resigned effective September 2 and was not placed on a leave of absence for military service.

In our letter dated September 22 addressed to Westbrook we advised that his services with our department were terminated and that if he so desired, he could make application to the Texas Teacher Retirement System for a refund of the payments he had made.

With respect to this case we will thank you to review the correspondence regarding Westbrook and give him a reply to his letter of October 22. Please send a copy of your reply to this office.

To date we have not received Westbrook's payment to the Teacher Retirement System which will be necessary to permit release of his final salary and expense payments. The amount due is \$7.25.

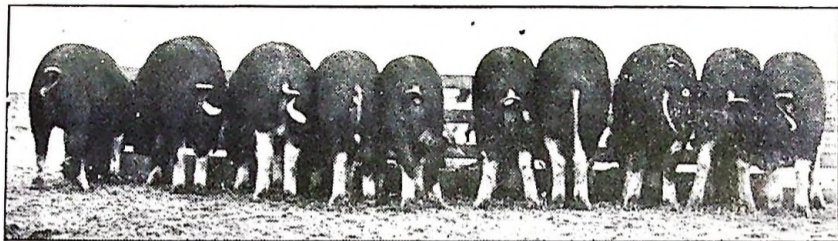

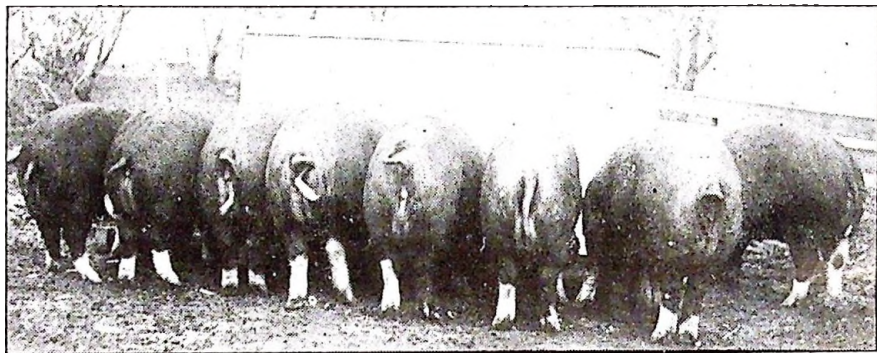

Der Mr. Williams:

At the request of Mr. E. M. Regenbrecht, Extension Swine Husbandman at College Station, Texas, we are mailing under separate cover a package containing registration blanks, applications for junior membership, breeding certificates, transfer blanks and folders explaining the method of filling out pedigrees.

Each boy or girl you have owning a pure bred Poland China and having a project is entitled to a Free Junior Membership in the Standard provided his Poland Chinas are recorded with this Association. These Free Junior Memberships entitle the boy or girl to record at Membership rates as long as they are affiliated with pig club work or until they reach the age of twenty-one years.

We shall be happy to issue Free Memberships to your boys and girls and all that is necessary is that you fill out a Junior Membership application for each member and send it along with his pedigree for registry and the fee for recording. If the animal to be recorded is under two years of age the rate is 75 cents or for an animal over two years of age the rate is \$1.50 for Junior Members.
