Dear Williams:

Received your letter relative to this present meat situation. I wish I could give you something definite but have nothing to base my statement on should I make one.


Director Williamson has just returned from the Land Grant College meeting in Chicago and while there he was advised that some type of educational meetings are going to have to be held very soon. They, of course, will involve information on ration, of which meat no doubt is going to be the first and major item. I am rather doubtful whether there will be any information available before November 10 but if there is, I am sure that it will be sent on to you immediately.

Here is my opinion. Farm people as well as city people are going to be asked to voluntarily curb their appetites on the products that are gradually becoming scarce. This will mean that all people, regardless of their status, are going to be asked to limit their consumption of meat to two and one-half pounds per week. Few people are eating more than this, generally speaking, and a large number of farm people will stay below this figure. My attitude is that if this is the good American spirit and what it takes to win this war, farm people are going to accept practically one hundred percent and growl very little about it.

If farm people have a visible meat supply for their families this coming year, I think they should go ahead and conserve it to the best of their ability. When it comes to eating it, I think that they should think of two and one-half pounds per week and adhere to it as close as conditions will permit.

As I said before, we will get this information to you as soon as possible after it is released.
